

OraCore Beta Participation Agreement

1. Beta Access

OraCore AI grants [PRACTICE NAME] complimentary access to OraCore Scribe during the beta period in exchange for the practice's participation as described below. No payment is required while this agreement is in effect.

2. Practice Commitment

I agree to provide ongoing, structured feedback as a condition of continued free access. This includes:

4. Confidentiality
